RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

Please read carefully before signing. Sheridan Creek Equestrian Center, LLC does not guarantee your

safety. As set forth below, you are taking all responsibility for your safety and the safety of your child(ren) and others while at this location and while participating in this activity. Serious injury and or death may result from your participation in this activity. After careful review, if you wish to accept the terms of this Agreement, please initial each paragraph and sign at the bottom of this Agreement.

THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT (this "Agreement") is legally binding on me, my heirs, representatives, successors and assigns. If I am signing this Agreement as a parent or guardian on behalf of a minor, this Agreement is also legally binding on the minor for whom I am signing and the heirs, representatives, successors and assigns of the minor. A. Released Parties.

The term "Released Parties" includes Sheridan Creek Equestrian Center, LLC, a Nevada limited liability company (referred to as "Sheridan Creek"), and its directors, officers, members, managers, sponsors, agents, employees, volunteers, representatives, affiliated persons or entities and others acting on behalf of Sheridan Creek.

B. Activities and Locations Involved In This Release.

The term "Premises" includes all grounds of Sheridan Creek whether currently owned or hereafter acquired, including without limitation, the stables, offices, appurtenant structures, rings, arenas, barns, tack rooms, stalls, storage areas, sheds, roads, adjoining driveways, parking areas, paths, trails, pastures, fields, paddocks and waterways. For purposes of this Agreement, it also includes all locations where the parties travel to in or to participate in or observe any activity in connection with Sheridan Creek.

The term "Affiliated Activity" refers to any activity involving horses on the Premises whether a party is on the Premises as a boarder, sponsor, rider, student, client, participant in any clinic, day camp, seminar, outreach program or other activity, employee, independent contractor, outside instructor or trainer, bystanders or anyone accompanying, visiting or in any way related to the above parties.

C. Application to Horses, Riding And Activities.

The term "horse" includes all equine species without regard to size. The terms "ride" and "riding" refer to all handling and care of equine species, whether mounted or not. I acknowledge that being around horses and horseback riding both contain inherent risks of injury and damage to me personally, to my child(ren), to bystanders, to my horse, to my equipment, to my vehicle(s) and horse trailer(s), whether or not caused by my own negligence or the negligence of others. There will be various activities involved in association with Sheridan Creek, including without limitation, driving and lodging at remote locations, and all activities associated with Sheridan Creek of any kind whatsoever and wherever located are subject to this Agreement.

D. Dealing With Horses Is A Dangerous Activity.

I understand, acknowledge and agree that being in the presence of horses as well as the handling, care and riding of horses is an inherently dangerous activity. I understand that horses are powerful, unpredictable and potentially uncontrollable animals of flight. All horses, even those that appear calm and docile, may buck, rear, bite, kick or bolt uncontrollably, without warning, and without apparent cause. Horses may also buck, rear, bite, kick or bolt in response to sound, wind, motor vehicles, equipment, bicycles, dogs, movements of people, machinery, doors, or other objects. I understand that serious injury to myself or my child(ren), and disability or death of myself or my child(ren) may result from being in the presence of, the handling, care or riding of horses.

E. Acceptance of Inherent Dangers of Horses and Horse Activities.

I HEREBY ACCEPT AND ASSUME ANY AND ALL RISKS, KNOWN AND UNKNOWN, OF INJURY, INCLUDING WITHOUT LIMITATION, SERIOUS AND PERMANENT BODILY INJURY AND DISABILITY, BONE AND JOINT INJURY, MUSCLE STRAIN AND MUSCLE INJURIES, BRAIN OR NEUROLOGICAL DAMAGE, PARALYSIS, ILLNESS, DISEASE OR DEATH TO MYSELF OR MY CHILD(REN) ARISING FROM OR RELATING TO BEING IN THE VICINITY OF HORSES, THE HANDLING, CARE OR RIDING OF HORSES, THE USE OR MISUSE OF ANY TACK OR OTHER EQUIPMENT (WHETHER PROVIDED BY SHERIDAN CREEK OR OTHERWISE), AND ANY AND ALL OTHER ACTIVITIES INVOLVING OR RELATING TO HORSES ON OR OFF THE PREMISES. I ALSO HEREBY ACCEPT ALL FINANCIAL LOSSES, KNOWN OR UNKNOWN, DUE TO INJURY, DAMAGE, DESTRUCTION, OR LOSS OF MY PROPERTY OR MY CHILD(REN)'S PROPERTY, ARISING FROM OR RELATING TO BEING IN THE VICINITY OF HORSES, THE HANDLING, CARE OR RIDING OF HORSES, THE USE OR MISUSE OF ANY TACK OR OTHER EQUIPMENT (WHETHER PROVIDED BY SHERIDAN CREEK OR OTHERWISE), AND ANY AND ALL OTHER ACTIVITIES INVOLVING OR RELATING TO HORSES ON OR OFF THE PREMISES.

I agree to wear and have my child(ren) wear a SEI certified ASTM standard equestrian helmet and proper footwear whenever mounting, riding, dismounting and otherwise being around a horse. I understand that wearing of such proper

headgear and footwear while engaged in any such activities may prevent or reduce the severity of some injuries in a horse-related accident, but I acknowledge and agree that even though a participant is wearing proper headgear and footwear, injuries or even death may result from a horse-related accident. The undersigned acknowledges that Sheridan Creek, at its option, may provide certain tack and equipment, including without limitation, saddles, bridles, stirrups, halters, girths, reins and other equipment for use by the undersigned or such child(ren). While the undersigned understands that Sheridan Creek takes reasonable precautions to ensure the safety and integrity of its tack and equipment, the undersigned acknowledges and agrees that Sheridan Creek does not guaranty or warrant in any way that any such tack or equipment will not break, fail or malfunction, resulting in possible injuries or even death as a result of such breakage, failure or malfunction. I understand that no horse is completely safe. A horse is much larger, faster and more powerful than a human. If a rider falls, or a horse has any type of contact with the rider, injuries, paralysis and even death may result. If a horse is frightened, angry, stressed or provoked, or for other reasons, including without limitation, weather, terrain, sounds, movement, unfamiliar objects and other animals, it may cause injury as a result of stopping suddenly, changing direction or speed, jumping forward or sideways, shifting its weight, bucking, rearing, spinning, kicking, biting, crushing, throwing, dragging or stepping on me or my child(ren). F. Responsibility for Other Circumstances and Conditions.

I understand that at Sheridan Creek, motor vehicles regularly enter and exit the stables in close proximity to the stalls and paddocks, and in the area where horses are groomed and ridden. Pedestrians, cyclists, delivery trucks, trailers, cars, dogs, wildlife, and other equestrians also enter the stables in close proximity to the horses on a regular basis. Inclement weather, including winds, rains, storms and associated blowing and falling debris from trees and brush, may occur on the Premises. Tractors, hay bailers and other equipment and machinery are used on a regular basis. Certain fencing owned by adjacent property owners may pose safety hazards over which Sheridan Creek has no control. Such motor vehicles, equipment and machinery, child(ren), horses, cyclists, delivery trucks, trailers, cars, dogs, wildlife, fencing and weather-related conditions may pose a danger to persons and may cause horses to react in an unpredictable manner without prior warning. The nature of the terrain on the Premises can change and has certain risks associated with it such as surface and subsurface objects, rocks, trees, streams and creeks. In addition, there are certain potentially dangerous conditions on or about the Premises, including without limitation, irrigation ditches which may be filled with water, and such conditions may be dangerous to persons (including children) who are riding, walking or playing on, near or around such conditions. I accept and assume any and all risk of injury, death and damage that may result to myself or my child(ren) as a result or arising out of any of the above circumstances and conditions, and any other circumstances or conditions, known or unknown, which are associated with participation in equestrian activities.

While participating in or attending certain activities in connection with Sheridan Creek, there will be times that I or my child(ren) will be off the Premises. So long as I or my child(ren) are participating in or attending a function associated with Sheridan Creek, this Agreement shall apply with respect to myself and my child(ren).

G. Release, Waiver & Indemnity Is In Exchange For Participation In Sheridan Creek Activities.

In exchange for being permitted to participate in Sheridan Creek activities, including use of the facilities and services on the Premises, the undersigned, for myself and my child(ren) and any respective heirs, representatives, successors and assigns: (a) give up any rights to make or file a claim, demand or lawsuit against Sheridan Creek, (b) waive for myself and my child(ren) the right to claim or seek money or other compensation for any injuries, harm, damages, destruction or loss, and (c) agree that if Sheridan Creek is sued or has a claim made against it that the undersigned will indemnify, defend and hold harmless Sheridan Creek from any and all claims made against it.

H. Binding Release, Waiver of Liability and Agreement To Indemnify, Defend and Hold Harmless.

IN FURTHER CONSIDERATION FOR BEING PERMITTED TO ENTER THE PREMISES FOR ANY PURPOSE WHATSOEVER, INCLUDING WITHOUT LIMITATION, OBSERVATION OR USE OF FACILITIES OR EQUIPMENT OR PARTICIPATION IN ANY AFFILIATED ACTIVITY ON OR OFF THE PREMISES, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. THE UNDERSIGNED, ON BEHALF OF ME AND MY CHILD(REN), HEREBY RELEASES, WAIVES, DISCHARGES THE RELEASED PARTIES from all liability to the undersigned or such child(ren) and all of our respective heirs, representatives, successors or assigns for any loss or damage, and any claim or demands therefore on account of injury to persons or property or resulting in the death of the undersigned or the undersigned's child(ren), whether caused by the Released Parties' negligence or otherwise, while the undersigned or such child(ren) are in, on or about the Premises or any facilities or equipment therein, or participating in or observing any activity in connection with Sheridan Creek, regardless of the location of such activity. THE UNDERSIGNED, ON BEHALF OF ME AND MY CHILD(REN), HEREBY AGREES TO INDEMNIFY, DEFEND AND HOLD HARMLESS THE RELEASED PARTIES, and each of them, from any and all claim, injury, loss, liability, judgment, cost, damage and expense (including attorneys' fees or costs), whether caused by the Released Party's negligence or otherwise, which the Released Parties may incur as a result of or arising out of the presence of the undersigned or such child(ren), or their respective guests or invitees, in, on or about the Premises, including without limitation, the use of any facilities or equipment of Sheridan Creek, or the participation in or observation of any activity in connection with Sheridan Creek, regardless of the location of such activity. THE UNDERSIGNED, ON BEHALF OF ME AND MY CHILD(REN), HEREBY ASSUMES ALL RISK OF AND FULL RESPONSIBILITY FOR ANY AND ALL BODILY INJURY, DEATH OR PROPERTY DAMAGE to the undersigned or such child(ren) whether caused by the Released Party's negligence or otherwise, while in, on or about the Premises or while using any facilities or equipment on the Premises, or participating in or observing any activity in connection with Sheridan Creek regardless of the location of such activity. The undersigned understands that the presence of any of Sheridan Creek's personnel is no assurance of the undersigned's safety or lessens any risk assumed by the undersigned. Agreed: _____

THE UNDERSIGNED, ON BEHALF OF ME AND MY CHILD(REN), FURTHER AGREES THAT THE FOREGOING RELEASE, WAIVER OF LIABILITY AND INDEMNITY is intended to be as broad and inclusive as is permitted by the laws of the State of Nevada and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full force and effort. I. Health Conditions.

The undersigned, on behalf of me and my child(ren), warrants that (a) neither the undersigned or the undersigned's child(ren) have any medical problems which might interfere with participation in any Sheridan Creek activity, (b) the undersigned and such child(ren) can fulfill any physical requirements involved with horseback riding activities, and (c) the undersigned and such child(ren) have consulted with their physician with respect to any health conditions which may be adversely affected by riding or other horse-related activities, and agrees to assume all risks in connection therewith. J. Representation of Competence; Understanding of Terms.

L. Possible Uses Of This Agreement.

I UNDERSTAND AND ACKNOWLEDGE THAT THIS IS A RELEASE OF LEGAL LIABILITY. IN THE EVENT OF ANY LITIGATION OR OTHER ACTION, THIS AGREEMENT MAY BE RAISED AS A DEFENSE, TENDER OF DEFENSE AND INDEMNIFICATION AND AS A BAR TO, AND AS A WAIVER AND RELEASE OF, LEGAL RIGHTS THAT MIGHT OTHERWISE BE ASSERTED BY ME, MY CHILD(REN) OR OUR RESPECTIVE HEIRS, REPRESENTATIVES, SUCCESSORS AND ASSIGNS. M. Choice of Law.

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Nevada. Agreed: _____

P. Attorneys' Fees.

In the event of a breach of this Agreement by the undersigned, or in the event Sheridan Creek must retain an attorney to enforce the terms of this Agreement, Sheridan Creek shall have the right to recover its attorneys' fees and costs from the undersigned. Agreed: _____

Q. Complete Agreement; Modifications.

The undersigned acknowledges and agrees that no other representations, understandings or agreements, whether oral or written, apart from the foregoing written Agreement have been made, and this Agreement represents the complete agreement with respect to the subject matter contained herein. Any modifications to this Agreement shall be in writing and signed by Sheridan Creek and the undersigned. Agreed: _____
